Alex Bryson is Professor of Quantitative Social Science at UCL's Social Research Institute, and a Research Fellow at the National Institute of Economic and Social Research, the IZA Institute of Labor Economics, and the Economic Statistics Centre of Excellence (ESCoE). He is Editor-in-Chief of Industrial Relations: A Journal of Economy and Society and an editor of the Journal of the Royal Statistical Society Series A and the Journal of Participation and Employee Ownership.

Job quality is strongly related with general wellbeing. Applying the method of 'dominance analysis' to employer-employee linked data, we investigate the importance of the workplace in accounting for variations in job quality, relative to that of occupations, employee characteristics and year. We find a high importance for establishments in determining both pay and non-pay dimensions (prospects, working time quality, autonomy and skill, work intensity, and the social environment.) The significance of this finding is that establishment-level policies may be an effective way to positively influence general wellbeing.
